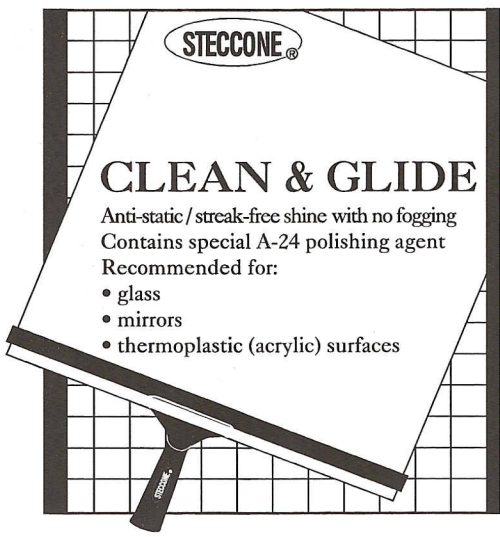

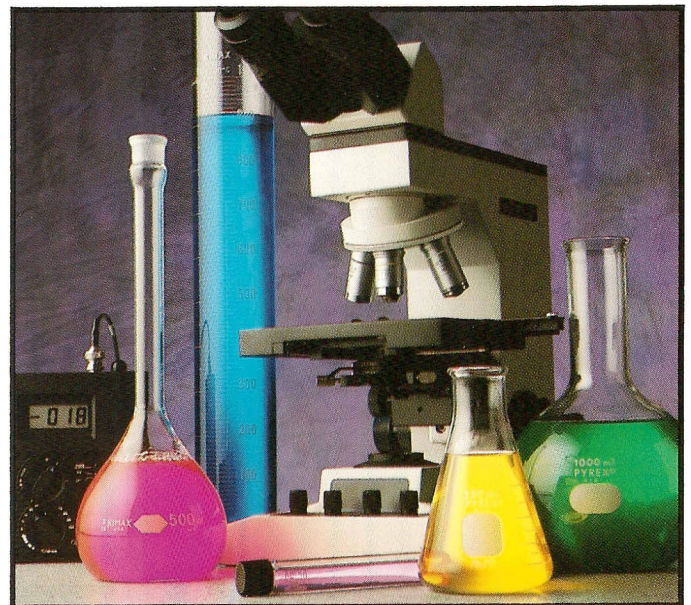

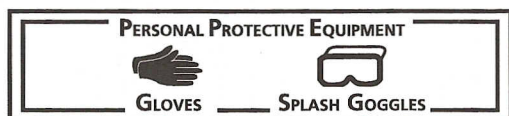
PRODUCT DATA
